#### When to use this form

Under section 22L of the *Classification (Publications, Films and Computer Games) Act 1995* (the Classification Act), the Classification Board can exercise its powers to revoke a decision made by an accredited person (classifier) upon application.

Under section 22L(8) of the Classification Act, a person who is:

- a participating Minister, or
- the publisher of the classified material

can make an application for revocation up to 3 months after the day the accredited classifier's decision took effect.

You can find the classification date of the decision on the National Classification Database at **classification.gov.au**.

#### **Classification Board process**

The Classification Board will check the content, and determine if the decision made by the accredited classifier is:

- not correct, and issue a Notice of Possible Revocation to the accredited classifier and publisher OR
- correct, and take no further action.

The Classification Board will notify you and other interested parties of the check outcome in writing.

If the Classification Board is considering revoking the accredited classifier's decision, the accredited classifier will be invited to make a submission as to why the decision should not be revoked.

The Classification Board will consider any submission made by the accredited classifier and either:

- revoke the accredited classifier's decision, and replace it with a Classification Board decision as per section 22L of the Classification Act OR
- determine the accredited classifier's decision is correct, and take no further action.

If you are not satisfied with the Classification Board's decision, you may be eligible to apply to the Classification Review Board for a review.
